#### Pupils at Catcott Primary School are happy and safe. The school values of curiosity, creativity and compassion shape the whole curriculum.

#### The very beginning

Ofsted praised our Early Years provision, the strong and caring relationships that are formed between home and school, the well thought out provision, and children's readiness for Year One.

#### The curriculum

Progress since the last inspection in reading, writing, and maths along with the foundation subjects, were praised by the inspectors.
